## A – General

In 2006, some owners of the classic small car DIXI or BMW 3/15 decided to found an interest group (IG) of owners of these cars as DIXI-IG. This foundation took place on 09.09.2006 in Eisenach. A so-called 1st and 2nd board was elected at that time, together with other board members, to take over the leadership of this IG. In the meantime, this community enjoys great popularity, the number of members has already grown considerably, with fortunately car owners from abroad also among the members.

An important task of the IG is the preservation, restoration and care of the historic vehicles as cultural heritage, combined with the demonstration also for the public within the framework of IG events and other opportunities.

The IG bears the name: **DIXI - Interessengemeinschaft** 

# It is the **international brand club for Dixi, BMW 3/15, Ihle and related special models.**

The rules and regulations of the IG are intended to be the basis and guideline for the DIXI interest group with its members.

## **B** - Objectives of the IG

- 1. The IG sees itself as a representative of the interests of its members, bringing about and promoting their cohesion.
- 2. The IG supports the members in the construction/restoration and preservation of the vehicles through mutual information, advice, hints, tips, etc.
- 3. The development of the community life of the IG is seen as an important task. For this purpose, two meetings of the IG members, if possible, with their vehicles, are to be organized and carried out annually at a different location by members on behalf of the board. In addition, through the initiative of the members and the board, but organized by local members, there will be regional meetings and trips, visits to trade fairs and museums.
- 4. There is a need for IG members to play an active role in the development of community life.



## C – Membership

- 1. Any person who owns a DIXI, a BMW 3/15, an Ihle or any of the usual special models, has an interest in these vehicles and may be involved in the purchase of such a vehicle or who only advocates or wants to advocate for the goals and purposes of the IG can become and be a member of the DIXI-IG.
- 2. There is no selection process for admission as a member. Membership in other motorsport clubs is not an obstacle to membership in the DIXI-IG.
- 3. For admission to the DIXI-IG, an application form must be completed and confirmed. In addition, a confirmed SEPA basic direct debit mandate for the annual membership fee as well as the declaration of consent to data protection must be attached to the application. The forms, including this set of rules and the bank details of the IG, are sent to the interested party by a representative of the board or can be downloaded from the homepage of the DIXI-IG.
- 4. The return of the confirmed application documents secures membership in the IG. By signing, the new member acknowledges this set of rules.
- 5. The admission fee is 25.00 EURO. Membership begins with the receipt of this contribution to the account of the IG, it is due immediately together with the first annual fee.
- 6. Membership ends by a written declaration of resignation by the member at the end of the calendar year, by death or by resolution of the board, if the member causes lasting damage to the reputation of the IG, violates these rules or does not comply with the payment of the dues. The member must be threatened with exclusion in writing in advance.

## **D** – Membership fee

- 1. The membership fee is 30.00 EURO per calendar year and will be collected from the member's account at the end of the first quarter of a year. If collection is not possible, the member must transfer the contribution independently on the same due date. Any costs incurred for return debits shall be borne by the member.
- 2. The annual fee is due in full even if the membership begins or ends in the course of the year.
- 3. If the annual fee is 12 months overdue and the member has not fulfilled his payment obligation within 6 weeks after a written reminder has been issued, the exclusion is given by resolution of the board.
- 4. In case of exclusion within a calendar year, there will be no refund of the pro rata annual membership fee.



## **E** - Board of Directors of the IG

- 1. The IG is led by a board of directors, which should have up to 4 members.
- 2. A general meeting to be held once a year should preferably take place in connection with the main meeting taking place in spring. Invitations must be issued at least 6 weeks in advance to this meeting, with the most important items on the agenda being announced.
- 3. The Assembly elects the members of the Board of Directors in an open vote. In the election , the simple majority applies. The General Assembly always has a quorum, regardless of the number of members present.
- 4. The Executive Board will use the financial resources carefully and responsibly. Once a year, on the occasion of the general meeting, an account is given of the use of funds and the financial stock. On the basis of the audit of the cash register and the use of funds by the person responsible for auditing and on his/her proposal, a vote must then be taken on the discharge of the person responsible for the cash register.
- 5. At the general meeting, the board of directors gives an accountability report. The discharge of the Executive Board must also be voted on.
- 6. The board members are elected for 2 years each. The 1st chairman is elected every odd year, the deputy, the treasurer and the homepage manager are elected every even year.

### **F** - Other arrangements

- 1. IG members consent to the collection of their personal information for IG internal purposes. Information about the members may not be disclosed to third parties.
- 2. IG members may use IG internal materials and other cost-incurring materials. Do not share information with third parties. This also applies to the code of the IG website.
- 3. It is permissible for the Executive Board to conduct binding correspondence with the members by e-mail or fax if this is technically possible. Votes and other votes can also take place in this way. For this purpose, a date must then be set for the reregistration.
- 4. The DIXI-IG can be dissolved by resolution of the General Assembly on the proposal of the Executive Board. The remaining financial resources are to be divided among the ordinary members (no non-contributory family members) on this date after all obligations have been settled, proportionately according to the duration of membership. The settlement shall take place by the end of the 3rd month following the adoption of the resolution at the latest. If assets or cash cannot be sold or paid out by this date, the remaining assets will be transferred to a non-profit organization or a museum, for example. The decision on the recipient shall be made by the Assembly together with the Dissolution order. The settlement is finally decided by the treasurer Report.
- 5. The seat of the IG is determined by the chairman of the board.
- 6. The association year is the calendar year.
